ADDITIONAL SPACE HAS GIVEN BIRTH TO NEW MINISTRIES AND ALLOWED OLD ONES TO EXPAND. EACH WEEK, THE MINISTRY CENTER HOSTS BIBLE STUDIES AND PROVIDES SPACE FOR PEOPLE TO MEET IN SMALL GROUPS OR TO STUDY. IN 2015, FAS SPONSORED THREE FORMAL RETREATS: TWO AT THE FAS MINISTRY CENTER (KY) AND ONE AT HEMLOCK INN (NC). FAS EVANGELISTS LED THESE RETREATS, AND MANY OF OUR BOOKS AND RESOURCES WERE PURCHASED BY THE ATTENDEES. THESE CONFERENCES INSPIRE SPIRITUAL RENEWAL AND A DEEPER, MORE MEANINGFUL CHRISTIAN LIFE FOR PASTORS AND LAYPEOPLE. THE MINISTRY CENTER ALSO CONTAINS A PRAYER CHAPEL WHERE FAS STAFF PRAY WEEKLY AND IT IS OPEN TO THE COMMUNITY. EXPENSES SHOWN BELOW ARE SPECIFICALLY RELATED TO PROGRAM EXPENSES THAT OCCUR IN THE MINISTRY

4b (Code:) (Expenses \$ 126,269. including grants of \$ 11,650.) (Revenue \$ 10,242.) FAS INTERNATIONAL: AT LEAST NINE INTERNATIONAL TRIPS TOOK PLACE IN 2015 UNDER THE FASI PROGRAM. THE PURPOSE OF THESE TRIPS FOCUSED ON EVANGELISM AND TEACHING. FAS SPEAKERS ARE OFTEN INVITED TO TEACH INTENSIVE COURSES IN LOCAL SEMINARIES OR AT GATHERINGS OF PASTORS TO TRAIN THEM IN EVANGELIZING THEIR OWN COUNTRYMEN. TW TAUGHT MULTIPLE BIBLE STUDIES IN MULTIPLE STATES AND HOSTED AN ON-LINE SEASONAL BIBLE READING PROGRAM INVOLVING HUNDREDS OF WOMEN. TW CONTINUED TO OVERSEE AND PROVIDE RESOURCES FOR THE LYDIA PRAYER MINISTRY ALONG WITH WRITING NEW BIBLE STUDY CURRICULUM FOR WOMEN TO USE.
